International Health Certificates

If traveling internationally with your pet your pet will need to meet the animal health requirements of the country you are visiting. This can involve getting a health certificate, updating vaccinations within a specific time frame, implantation of a microchip, completing disease testing, passing the required physical exam and associated diagnostic tests, along with having your paperwork reviewed and endorsed by Animal and Plant Health Inspection Services (APHIS). Often specific timing and dates or exams and vaccines are essential to your travel paperwork for your pets.

Most international health certificates must be completed in **ten days or less** prior to your travel date. This handout is meant to help aid you through this process. Please use the resources below to help guide you through this process. After receiving a health certificate from our office you generally must have your pet's health certificate endorsed by the USDA. For an endorsement from the USDA office you have the option of mailing the documents, dropping off documents and picking up next day, or scheduling an appointment (*information below*).

Microchip Implantation -We offer Homeagain Microchips (ISO compatible) for international travel.

European Microchip Requirements -For most countries the International microchips must be implanted prior to Rabies vaccination. If a microchip has been implanted for the first time, then **21 days must have elapsed** after the Rabies vaccine, before the health certificate can be issued - *Regardless of whether the animal was up-to-date on its Rabies vaccine previously.*

U.S. Department of Agriculture (USDA) **The USDA is expected to have the most current information for the requirements of each country.*
